

TRAFFIC MANAGEMENT ORDER

The City of London (Free Parking Places) (Disabled Persons)

(Amendment No. 6) Order 2025

Made: 23rd January 2025

Coming into operation: 27th May 2025

The Common Council of the City of London Corporation, after consulting the Commissioner of Police for the City of London, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(**a**) and section 8 of, and Part I of Schedule 5 to, the Local Government Act 1985(**b**), and of all other powers thereunto enabling hereby make the following Order:-

- 1. This Order may be cited as The City of London (Free Parking Places) (Disabled Persons) (Amendment No. 6) Order 2025 and shall come into operation on 27th May 2025.
- 2. In this Order, "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument, having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, reenacted by or as having effect by of any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of London (Free Parking Places) (Disabled Persons) (No. 4) Order 2013 (as amended) (c) shall have effect as though the items in Schedule 2 to that Order numbered 44, 45, 46A and 47 there were substituted the items similarly numbered and set out in Schedule 1 to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order further amends The City of London (Free Parking Places) (Disabled Persons) (No. 4) Order 2013 (as amended), in the City of London in:-

Finsbury Circus to:

- (a) Relocate north-eastwards and introduce an additional disabled persons parking place on the north-west side of the outer edge of the rotunda.
- (b) Revoke two disabled persons parking places on the south-west side of the outer edge of the rotunda.
- (c) Relocate the two disabled persons parking places from the eastern arm to the outer edge of the rotunda, the north-east side, from a point 35 metres north of the northern kerbline of the eastern arm of Finsbury Circus north-westward for a distance of 13.2 metres.
