## **The City of London (Free Parking Places) (Motor Cycles) (Amendment No. 12) Order 2025**

Made: 23<sup>rd</sup> January 2025

Coming into operation: 27<sup>th</sup> May 2025

---

The Common Council of the City of London Corporation, after consulting the Commissioner of Police for the City of London, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and section 8 of, and Part I of Schedule 5 to, the Local Government Act 1985(b), and of all other powers thereunto enabling hereby make the following Order:-

1. This Order may be cited as The City of London (Free Parking Places) (Motor Cycles) (Amendment No. 12) Order 2025 and shall come into operation on 27<sup>th</sup> May 2025.
2. In this Order, “enactment” means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument, having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of London (Free Parking Places) (Motor Cycles) (Consolidation No. 1) Order 2017 (as amended) (c) shall have effect as though:-
  - (a) for the items in Schedule 1 to that Order numbered 23, 24 and 25 there was substituted the item similarly numbered and set out in of the Schedule to this Order; and
  - (b) the items numbered 21 and 22 in Schedule 1 to that Order are hereby revoked.

## SCHEDULE 1

(see Article 3)

### Designated Motor Cycle Parking Places

1 No. of Parking Place	2 Designated Parking Places
23	Finsbury Circus the inner or garden side, bounded by the edge of the carriageway that extends from a point 17 metres east of the boundary of property numbers 15 and 16 Finsbury Circus, in a clockwise direction for a distance of 36 metres.
24	Finsbury Circus the inner or garden side, bounded by the edge of the carriageway that extends from a point 4 metres north of the north side of the west gateway clockwise for a distance of 23 metres.
25	Finsbury Circus the eastern arm, the south side, from a point 6 metres east of the outer kerb-line of the rotunda eastward for a distance of 27 metres.

### EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order further amends The City of London (Free Parking Places) (Motor Cycles) (Consolidation No. 1) Order 2017 (as amended), in the City of London in **Finsbury Circus**:-

- (a) extend the motor cycle parking place on the south side of the eastern arm by 12 metres.
- (b) shorten the motor cycle parking place on north eastern rotunda opposite number 18 on the inner or garden side by 9 metres, to a total length of 36 metres.
- (c) relocate the motor cycle parking place on the east side of the inner or garden side to a point 4 metres north of the north side of the west gateway, extending clockwise for a distance of 23m.
- (d) revoke the motor cycle parking places on the north side of the inner or garden side on both sides of the north gateway.
